## **CERTIFICATION OF NO RENT COLLECTED (T3) ANNUAL EXEMPTION**

### **- INSTRUCTIONS -**

The Certification of No Rent Collected (Notice) provides property owners with the ability to request four (4) or more T3 exemptions per calendar year. The Notice must:

- Only use for T3 exemption requests for four (4) or more units within the one Assessor Parcel Number (APN);
- Reflect the occupants and actual unit(s) that will not have rent collected for the full calendar year (January-December);
- Valid Public Notary seal, date and signature; and,
- Submitted to the Los Angeles Housing Department's Billing and Collections Section
