Tenant Resources

- Report housing code violations for occupied units to LAHD. LAHD is responsible for investigating complaints about unsafe living conditions and code violations at multifamily rental properties within the City of Los Angeles. File a Code complaint and let an inspector assess the situation by calling (866) 557-7368 or online at bit.ly/LAHDComplaint.
 - For single family homes and vacant and damaged buildings, report violations to the Department of Building and Safety (LADBS) bit.ly/LADBSComplaint.

Landlord and Property Owner Resources

- LAHD is prioritizing and expediting applications for Resident Protections Ordinance Replacement Unit Determinations (RUD) and Mello Act Determinations. The RUD that will be issued for the fire affected areas will be an abbreviated version of a typical RUD, as deed restrictions of affordable replacement units is not required. However, the right of first refusal for low income tenants is still applicable. If a Mello Act Determination is required, concurrent review with the RUD is acceptable.
