- (b) A right of first refusal for a comparable unit (i.e. same bedroom type) in the new Project at an affordable rent pursuant to California Health and Safety Code Section 50053 or an affordable housing cost pursuant to California health and Safety Code Section 50052.5, as applicable (an "Affordable Protected Unit").
