



**DECLARATION OF NO AFFORDABLE PROTECTED UNITS
(Palisades Fire Rebuild)**

I/We _____, hereby declare as follows:

1. I/We am/are the owner of record of the single family dwelling (“Existing Project”) that existed prior to the Palisades fire in January 2025, located at and commonly known as _____, in the City of Los Angeles, County of Los Angeles, State of California, which is legally described in Exhibit “A” hereto (the Existing Project and the real property on which the Existing Project is situated, are hereinafter collectively referred to as the “Property”). I/We have personal knowledge of the facts set forth herein and if called as a witness in this matter, I/We would and could competently testify as follows:

I/We acknowledge and understand that unless an exemption applies, pursuant to California Government Code 66300.5 and 66300.6 and Los Angeles Municipal Code Section 16.60, in order to develop the Project, I/We am/are required to provide all occupants of "Protected Units" (as defined in California Government Code 66300.5) that occupied the Property immediately prior to the fire in January 2025, who are also Lower Income Households as defined in Section 50079.5 of the California Health and Safety Code, with the following:

- (a) A right of first refusal for a comparable unit (i.e. same bedroom type) in the new Project at an affordable rent (non-deed restricted) pursuant to California Health and Safety Code Section 50053 or an affordable housing cost pursuant to California Health and Safety Code Section 50052.5, as applicable (an "Affordable Protected Unit").

5. I/We have no obligation to provide any Affordable Protected Units at the Project, because throughout the entirety of the past five (5) years from the date I/we purchased the Property on _____ until _____ (Submittal Date) which is the date I/We submitted my/our application for a Replacement Unit Determination to the Los Angeles Housing Department:
